Dear Mr. Hall:

Thank you! Endowed funds are vital to Averett's long-term financial stability, and your sustained commitment ensures we are able to recognize Averett students and nurture their ability to achieve academic excellence. Many Averett students are benefiting from the generosity of individuals like you who support endowed funds. Averett distributes a significant portion of financial assistance to students annually through these funds which are increasingly important to students and their families. Incredibly, nearly 100% of our students qualify for financial assistance.

As donors, you are keenly aware of the challenges faced during 2022 in almost every sector of the market. Rising inflation and increasing interest rates had a widespread impact on domestic equities and bonds, but fourth quarter rebounds were encouraging. Averett's losses overall for calendar year 2022 were -9.9%. While the losses are disappointing, we are fortunate—our asset allocations and manager performance resulted in those losses being less than the -16.6% loss for the applicable benchmark indices. Therefore, it will likely not surprise you that the June 30, 2022, market value of your scholarship fund is down from the same time in 2021 (except in those cases where additional gifts may have offset the losses experienced).

Enclosed for your review is a financial and recipient summary for your personal endowment(s) at Averett for 2022-23. It is our hope that this information will allow you to learn more about your recipient(s) and give you even greater insight to the impact your gift is making.

Please know how much we appreciate your investment in our present and future.
